

POLICE REPORT — DEATH THREAT, STALKING, AND TERRORISTIC THREATS

1. SUMMARY OF INCIDENT

On 2026-08-02, between 4:31 PM and 4:34 PM (Central Time), the Reporting Party received:

- **11 phone calls from Bri Bosma** at +1 612-716-9997 between 4:31 PM and 4:34 PM CST on August 2, 2026, during one of which she left a 31-second voicemail in which Evan Bosma is heard in the background stating verbatim "I'm gonna fucking kill you, bitch"
- **A written text-message/SMS** to the same number with the same death threat verbatim
- **A declined phone call** at 4:34 PM from Bri Bosma's number
- **A phone call** at 4:32 PM from Evan Bosma

The threats were made in direct response to the Reporting Party's publication of a consumer-warning website documenting alleged regulatory violations by the subjects' business (Nutrition Excellence LLC, operating as "Nutrition Elements" / "Moonshot Gummies"). The threats reference the Reporting Party's identity ("Aladdin"), the consumer-warning website, and threaten physical violence.

This incident is reported in conjunction with **active consumer-protection complaints** the Reporting Party has filed with:

- Minnesota Office of Cannabis Management
 - North Dakota Department of Agriculture (John Mortenson)
 - Minnesota Department of Health (complaint filed)
 - Federal Bureau of Investigation (Minneapolis Field Office)
 - U.S. Food and Drug Administration (Office of Criminal Investigations)

2. STALKING / THREAT-RELATED CRIMES (Minnesota Statute)

Based on the conduct described, the following Minnesota criminal statutes may apply:

Minnesota Statute § 609.713 — Terroristic Threats

> "Whoever threatens, directly or indirectly, to commit any crime of violence with the purpose to terrorize another or to cause evacuation of a building, place of assembly, or facility of public transportation, or otherwise to cause serious public inconvenience, or in reckless disregard of the risk of causing such terror or inconvenience, is guilty of a felony."

The voicemail, in which Evan Bosma states verbatim "I'm gonna fucking kill you, bitch" while Bri Bosma is on the line, constitutes a direct verbal death threat. This statute applies regardless of whether the subject intends to carry out the threat — the **purpose to terrorize** is evident from the text-message context referencing the consumer-warning website.

Minnesota Statute § 609.749 — Stalking

> "A person who stalks another is guilty of a felony."

Stalking requires (1) repeated conduct, (2) directed at a specific person, (3) that would cause the target to feel frightened, threatened, or to suffer substantial emotional distress. The subjects' pattern includes:

- Repeated SMS contact over the documented period (December 2025 through August 2026)
- Continued contact after being informed of the consumer-warning publication
- Direct verbal death threat with no ambiguity

Minnesota Statute § 609.2231 — Assault, 4th Degree (Fear of Bodily Harm)

> "Whoever commits an assault as defined in section 609.223, subdivision 1, is guilty of a misdemeanor."

A verbal threat of death, when accompanied by the means and apparent ability to carry out the threat (subjects live in the same metropolitan area), may constitute assault under this statute.

Federal — 47 U.S.C. § 223(a)(1)(C) — Telephone Harassment

If the threats were transmitted via interstate communication (cellular voice or text), federal wire harassment statutes may apply.

You're simply an employee who has now taken advantage of any trust that was given to you, and here you are fucking ruining our lives, and you better bet. You will go down for this. I can promise you that right fucking now. Get yourself out of our lives, restore our fucking website before you go to fucking prison."

- **Embedded audio:** 31-second voicemail plays within the message thread
- **Notification shown:** "1 of 75" messages in the conversation history

EVIDENCE 4 — Verbatim Text of Voicemail

Based on the SMS-embedded playback, the 31-second voicemail contains the death threat ("I'm gonna fucking kill you, bitch") spoken by Evan Bosma in the background while Bri Bosma was on the line, followed by extended verbal abuse referencing the consumer-warning website and threatening the Reporting Party with prison. A full transcript should be obtained from the voicemail system by law enforcement via subpoena to the carrier.

5. CONTEXT — WHY THIS IS HAPPENING

The threats were made in direct response to the Reporting Party's publication of consumer-warning materials documenting alleged regulatory violations by the subjects' business. The materials are public at:

The threats themselves are **additional evidence** of consumer-protection conduct: Bri Bosma's text-message specifically references "this fucking website" and demands the Reporting Party "restore our fucking website before you go to fucking prison" — confirming the Reporting Party's role as a consumer advocate and the subjects' awareness of the public-interest publication.

The Reporting Party has previously filed the following complaints regarding the subjects' business:

- FDA MedWatch complaint (consumer-protection, food/drug misbranding)
- FBI Minneapolis Field Office tip
- Minnesota Office of Cannabis Management
- North Dakota Department of Agriculture (contact: John Mortenson)

- Minnesota Department of Health

These regulatory complaints are documented in the same evidence archive and demonstrate a pattern of conduct, not an isolated dispute.

7. WHAT TO DO RIGHT NOW (Reporting Party)

1. **If you have not already, call 911.** Tell dispatcher: "I have just received a death threat by voicemail and text message. The caller is Bri Bosma at 612-716-9997. I have audio evidence and screenshots. I am in fear for my safety."
 2. **Do not delete the voicemail.** It is on your phone and backed up to Google cloud (if enabled). Subpoena to Verizon can recover the original if deleted.
 3. **Do not engage with the subjects further.** Do not respond to texts or calls. Do not take down the website. Do not delete the website (that destroys evidence).
 4. **If you feel physically threatened, leave your current location and call 911 from a safe place.**
 5. **Document any further contact.** Every subsequent call, text, or approach from the subjects becomes additional evidence.
